Please note, **effective on April 1, 2021**, the Administrative Board of the Courts approved rule changes proposed by the Lawyers' Fund which have expanded New York's Dishonored Check Notice Reporting Rule to include reporting of overdrafts on all attorney trust, special and escrow accounts. The new rules also prohibit attorneys from carrying overdraft protection on attorney trust, special and escrow accounts.
