PETITION

For an Order Pursuant to NYCRR 1200 Rule:
1.15(G) for the Designation of a Successor:
Signatory.

The petition of EVE RACHEL MARKEWICH, as Executor of the Last Will and Testament of ROBERT MARKEWICH, respectfully states:

1. The petitioner resides at 173 Riverside Drive, New York, New York 10024. I am an attorney in good standing admitted to practice law in New York with offices at 18 East 48th Street, New York, NY 10017.

2. No prior application for the relief sought herein has been made.

3. Robert Markewich (sometimes "Decedent") died testate, a resident of New York County on April 23, 2011. Letters Testamentary were issued to the Petitioner and Iris Markewich by the Surrogate's Court of New York County on June 22, 2011, and remain in full force and effect (See Exhibit 1). I accept being designated as Successor Signatory.

4. Prior to his death, Robert Markewich had been a licensed attorney with an office at 175 Riverside Dr. New York, NY. He did not retire

from the practice of law but, upon information and belief took on no new matters after approximately 2006.

5. The Decedent was the sole stockholder and officer of a Professional Corporation known as "Markewich Friedman & Markewich P.C."

6. Among Decedent's papers Petitioner found a bank statement for an account maintained at Amalgamated Bank entitled "Markewich Friedman & Markewich P.C., IOLA Fund Account" bearing account number 3025970 with a balance of \$3,679.49.

7. An extensive search has been conducted of the Decedent's books, records and files in an effort to discover the identity of the true owners of such funds, to no avail.

WHEREFORE, it is requested that the Court grant an order pursuant to 22 NYCRR Art 1200 designating Eve Rachel Markewich as successor signatory of the Markewich Friedman & Markewich P.C., IOLA Fund Account maintained at Amalgamated Bank, directing that Eve Rachel Markewich deposit the funds from such account with THE LAWYERS' FUND FOR CLIENT PROTECTION for safeguarding and disbursement to persons who are entitled thereto, after deducting the costs and expenses for bringing this application, ^{\$210.00 for}


